Information concerning the revised BR18 directive

It is the customer's responsibility to ensure that the use of our products is done in accordance with, but not exclusive to, the Danish Executive Order on Building Regulations 2018 (BR18) www.bygningsreglementet.dk. We advise our customers to seek professional advice and/or information concerning relevant building codes, BR18, and applicable laws before purchasing and installing our products.

If our product is used in a manner that conflicts with current law and/or BR18, the customer cannot make any claims towards UnikFunkis A/S. Please note that according to BR18, as of the second of February 2021, there will in most cases be a requirement to use triple pane windows in new builds and renovations alike.

Carbon footprint of new buildings (GWP)

From 2023, it is a legal requirement that the climate footprint of new buildings must be calculated and declared. We refer to the standard industry environmental product declarations, which can be found on EPD Denmark's website. The link is available at www.unikfunkis.dk/en/legal-requirement. It should be noted that the EPDs are based on a representative standard window. Deviations in e.g. construction and glass construction, can thus affect the values.

Terms of delivery

Considering the extraordinary supply chain conditions, we are experiencing delivery failures and delays from our subcontractors. Therefore, in all confirmed orders the agreed delivery date may be greatly delayed and/or we may be justified to make partial deliveries. We claim the right to do this in cases where our subcontractors fail to deliver to us as specified. We are not answerable to any claims from the customer in cases of delayed delivery.

All elements are illustrated as seen from the outside

Unless otherwise noted, all products are delivered as UnikFunkis standard, certified by DVV (the Danish certifying body for window products) and guaranteed per standard window industry practice, terms of sale and delivery according to DVV (www.dvv.dk). Any dispute will be adjudicated at UnikFunkis' venue, the municipal court of Viborg, and according to Danish law. Exceptions may apply to custom specifications, safety glass, emergency escape exits, and ventilation. UnikFunkis is not liable for inventory counts performed by the company. The elements are not bearing structures, and UnikFunkis is not liable for static calculations and the impact of wind pressure. Changes made to elements and subsequent installation of additional equipment void the warranty. If extra accessories are mounted on UnikFunkis elements, careful consideration should be given to how placement and function affects the current element. If retrofitted accessories damage/reduce the functionality, lifespan or safety of the element, the warranty is void. There is no warranty on sealing performance and warping for doors with single point locks. For elements that open into the building, water may drip off during opening. This is not a product defect and is not eligible for warranty claims.

Electronic accessories

A one year warranty is provided for electronic/electrical components and accessories. Misuse or lack of proper maintenance will render the warranty void.

Color coverage

Elements painted with opaque colors are to be re-painted as needed. The maintenance schedule will depend on the exposure to sun, wind, and water. Please refer to "Forventet udfald af industrielt overfladebehandlede træelementer" (Typical durability of industrially surface treated wood elements) at www.dvv.dk (in Danish).

Reservations concerning anodized aluminum profiles:

There are color and nuance variations in the surface treatment, and there will be color and nuance variations from order to order. Extrusion tracks/pressure marks are visible on anodized aluminum profiles. In addition to this, small scratches and surface marks are not entirely avoidable in the machining process.

Coastal area

Elements in coastal environments, maintenance is to be expected with frequent interval. Reduced lifetime of fitting and paint is to be expected. In special aggressive environments, such as indoor pool areas and saunas, the warranty is void.

Loose glass panes

Panel doors

Panel doors are delivered with a surface treated veneer with the look of wood grain. Alu clad elements always have veneer on both sides of the door leaf. Frequent maintenance should be expected, to avoid cracking in the paint and veneer. In general, dark colors are more exposed than lighter colors. Damage caused by lack of maintenance are not covered by the product warranty. For the colors RAL 7016, 7021, and 9005, there is a reduced warranty of 2 years.

Glass in general:

Glass is supplied in accordance with the DVV Guarantee. Thermal breakage is not covered by the DVV guarantee. Furthermore, please refer to the Technical Specifications Appendix 20: Visual quality deviations in insulated glazing and glass.

Aluminum plate on top of threshold

Aluminum plate is fitted on the top of threshold on outward opening doors. However, the folding and double doors the aluminum plate is loose, due to easier installation and safe assembly of the bottom threshold.
